DIVER'S LIABILITY RELEASE, ASSUMPTION OF RISK AND HOLD HARMLESS
AGREEMENT**

Please read carefully, fill in all blanks, initial before each paragraph and sign.

hereby agree as follows:

___ I knowingly, freely and voluntarily, for myself, my heirs, personal representatives and assigns, hereby waive any and all rights or claims I may have against Lake Denton Management, Inc., Lake Denton Camp, Orange Blossom Baptist Association, and their employees, officers, agents, contractors or assigns (hereinafter "Released Parties"), for any and all personal injury, death or property damage I may suffer or sustain as a result of my being on the premises, my participation in scuba and snorkeling activities, and the negligence of the Released Parties, whether passive or active.

___ I hereby affirm that I have been advised and thoroughly informed of the inherent hazards on the property, which is not improved, including but not limited to: extremely hot, humid or stormy weather; loose rocks; fallen timber; fire; venomous, stinging or disease carrying animals or insects; poisonous plants; wild animals, including alligators and snakes; and other natural or man-made hazards and dangers. I understand that hazards (both on land, and above and below water level) may not be marked and weather is always unpredictable. Accordingly, I agree to exercise due care while on the property, to be cautious, to avoid and/or voluntarily accept the inherent risks of using the property.

___ I understand that SCUBA diving involves certain risks and is inherently dangerous. Injuries can occur that require treatment in a recompression chamber, which may not be conveniently available. I hereby assume all risks of injury to myself, including but not limited to, death by drowning or other cause or other accidents, such as air embolism, the bends, or other related diving injuries, and to my property, in connection with all diving activities, for any harm that may befall me as a result of my participation in any activity on site, whether foreseen or unforeseen. I still choose to proceed with these activities in spite of the absence of a supervision on site and a recompression chamber in close proximity. I agree to exercise due care while on or in the water, to be cautious, to avoid and/or voluntarily accept the inherent risks of skin and scuba diving. Furthermore, I will dive within the limits of my training and experience.

___ I hereby agree, for myself, my heirs, personal representatives, and/or assigns, from the date of this Agreement and forever hereafter, to indemnify, hold harmless and blameless, and to release from liability, the Released Parties for any injury to myself, including death, that may occur as a result of my use of the property and/or participation in scuba diving activities, however caused, including the negligence of the Released Parties. If I, my heirs, personal representatives, or assigns institute any action against the Released Parties arising out of injury to me or damage to my property as a result of my use of the property and/or scuba diving, I, for myself and my heirs, personal representatives and assigns, HEREBY AGREE to pay all costs of such action, including attorney's fees incurred by the Released Parties.

___ I hereby state that I am of lawful age and legally competent to sign this liability release, or that I have acquired the written consent of my parents or guardians, who have also signed this agreement. I understand the terms herein are contractual and not mere recital and that I have signed this document of my own free act and with the knowledge that I hereby agree to waive my legal rights. I further agree that this Agreement shall be governed by Florida law and, if any provision is found to be unenforceable or invalid, that provision shall be severed from this Agreement and the remainder of this Agreement will then be construed as though the unenforceable provision had never been contained herein.

____ I understand and agree that I am not only giving up my right to sue the Released Parties but also any rights my heirs, assigns or beneficiaries may have to sue the Released Parties resulting from my injury or death. I further represent I have the authority to do so and that my heirs, assigns and/or beneficiaries will be estopped from claiming otherwise because of my representations to the Released Parties.

I INTEND FOR THE RELEASED PARTIES TO RELY UPON THE REPRESENTATIONS HEREIN MADE BY ME IN ALLOWING ME TO PARTICIPATE IN SCUBA DIVING ACTIVITIES ON THE PREMISES and I understand and agree the terms and conditions of this Agreement will remain in effect for the entire time period identified below and for all activities in which I participate on the premises of Lake Denton Management, Inc.
